- Modern language association (MLA)
- American psychological association (APA)

How to format your documents in APA format:

The steps mentioned below need to be followed to format your essays in American psychological association (APA) style:

#### The margins of the document

A paper that is formatted in APA style should have one-inch margins on all sides of the document. This is to ensure that the paper looks professional and all the APA guidelines are followed by the skilled writers.

### **Double spaced document**

All APA-style papers are to be double spaced. The headings of the documents need to be double spaced as well. The writer also has to ensure that they do not leave a single page as unformatted as it leaves a bad impression on the person who will be checking your work.

#### **Indented paragraphs**

All the paragraphs in an APA-style formatted paper need to be indented. The indent should be 0.5 inches. The writers should always remember to follow the guidelines of the APA format if the instructor has stated in the instructions.

#### Always add an abstract at the start of the paper

Unlike other format styles like MLA and Chicago, the APA format essays and papers start with an abstract. #### Accessible font should be used
